Founding Pet Parent & Early-Access Registration

“PetScion” refers to [**Shribalajipetscionincorporated inc.**], operating under the PetScion name.

PetScion ("PetScion," "we," "us," or "our") respects your privacy and is committed to responsibly handling the personal information you provide when registering as a Founding Pet Parent or joining our early-access community.

This Privacy Statement applies specifically to information collected through PetScion's pre-launch Pet Parent registration forms, including forms accessed through QR codes at events, community activities, farmers markets, promotional materials, or PetScion webpages.

1. Information We Collect

When you register, we may collect information you voluntarily provide, including:

Pet Parent Information

- First name
- Last name, if provided
- Email address
- Telephone number, if provided
- City
- Province

Pet Information

- Pet/animal name
- Animal type
- Breed, if provided
- Number of animals

Pet-Care Interests

We may collect information about services in which you are interested, such as:

- Grooming

- Dog walking or other applicable pet walking services
- Pet training
- Boarding
- Pet sitting
- Veterinary services
- Pet insurance
- Pet food and accessories
- Other pet-care services

2. Why We Collect This Information

PetScion may use the information collected through the early-access registration process to:

- Register you as an interested or Founding Pet Parent;
- Understand demand for different pet-care services;
- Understand the types of animals PetScion users care for;
- Determine the cities and provinces where there is interest in PetScion;
- Plan and develop PetScion's platform, services and launch;
- Contact you regarding your registration or requests;
- Inform you when relevant PetScion services become available, where permitted;
- Manage the PetScion early-access program;
- Maintain appropriate business, security and compliance records; and
- Comply with applicable legal requirements.

We will not require information that is unnecessary for the purposes of the early-access registration.

3. Marketing Communications

Joining the PetScion early-access community does not require you to consent to general promotional marketing.

If you separately choose to receive PetScion marketing communications, we may use the contact information you provide to send you PetScion news, launch announcements, promotions, offers, events and pet-care information.

You may withdraw your marketing consent or unsubscribe from marketing communications at any time.

Withdrawing marketing consent will not remove you from the PetScion early-access registration unless you separately request that we delete or close your registration, subject to applicable legal and record-retention requirements.

4. Sharing of Information

PetScion does not sell or rent personal information collected through this early-access form.

We may disclose personal information to service providers that assist us in operating our business and technology, such as providers of website hosting, form processing, cloud storage, communications, security, analytics or other technology services.

These providers may process information on PetScion's behalf for the purposes for which they have been engaged.

We may also disclose information where required or permitted by applicable law, including in response to lawful requests from government, regulatory or law-enforcement authorities.

PetScion will not share your early-access information with pet-care providers for the purpose of allowing those providers to independently market to you unless we provide appropriate notice and obtain consent where required.

5. Storage and Safeguards

PetScion uses reasonable administrative, technical and organizational safeguards appropriate to the nature of the information in its possession.

No method of electronic storage or transmission is completely secure. Therefore, PetScion cannot guarantee absolute security.

6. Retention

PetScion will retain personal information only for as long as reasonably necessary for the purposes for which it was collected and for applicable legal, security, accounting and business requirements.

When personal information is no longer required, PetScion will take reasonable steps to securely delete, destroy or anonymize it, as appropriate.

7. Access and Correction

You may contact PetScion to request access to personal information PetScion holds about you or to request correction of inaccurate or incomplete personal information, subject to applicable legal exceptions.

8. Withdrawal of Consent and Deletion Requests

Where PetScion relies on your consent, you may withdraw that consent, subject to applicable legal or contractual restrictions and reasonable notice.

You may also contact PetScion regarding deletion of information associated with your early-access registration. Certain information may need to be retained where permitted or required by law or for legitimate record-keeping purposes.

9. Children

The PetScion Founding Pet Parent / early-access registration is intended for adults.

Individuals under the age of 18 should not independently submit the early-access registration form.

10. Changes to This Privacy Statement

PetScion may update this Privacy Statement as its services develop or its privacy practices change.

If we make material changes affecting information previously collected, we will provide appropriate notice and obtain additional consent where required by applicable law.
